Athletic – James Brown/David Donato/Ivan Hampton – Mr. Hampton reported. We didn't have a meeting this month. Charley went over personnel for football and fall sports.

Buildings & Grounds — Steve Kondrosky/Mindy Sturgess — Mr. Kondrosky reported. We met this afternoon, Mr. Balogh and myself and he give me a list of things that they concluded. 11th ward school, they were having a weed problem and they took care of that. They took care of promenade and graduation, New band platform construction in the stadium lot, D.A.R.E Graduation, George Washington School barriers were put in place and signs were posted, doors were hung inside the bathrooms near the cafeteria, Warranty roof inspection and Founders Hall and the High School were completed. The High School main office was snaked, there was a problem there, a pretty substantial one too. At the Administration building a cast iron pipe leaked some product in the ceiling and A1 and Haughey was out to take care of that. They assisted Dick's Sporting Goods with tables, signs, hung tents and moved equipment. They did a tremendous job working for them while preparing for that event. New ice machine was set up in the Training Room. The roof was drained at Twin Rivers because of that disaster we had a few Monday's ago. Roof leaks at Founders and Twin Rivers were repaired and ceiling tiles were replaced. The batteries in the emergency generator at Twin Rivers had to be replaced because they were fried from the storm. Currently they are in the summer cleaning mode.

Community Relations/Cultural Diversity – Mindy Sturgess/Ivan Hampton/David Donato – Mrs. Sturgess reported. We met as a committee as a whole. I didn't have time to take detailed notes, Dr. Wanzo agreed to provide those updates. Dr. Wanzo reported. The diversity equity inclusion team of teachers met with the voices of change students and we continued to meet via zoom, we will be meeting to discuss articles or current events and a formal meeting in August to continue to form our vision and mission statement and we continue to collaborate with Penn State.

Our PM program with Dick's Sporting Goods is thriving as well some of the things they have done, speed painting, tie-dye, outdoor exploration day, fishing with Brett Kiesal, field trips at the farm, zoo, science center, tonight as Dr. Holtzman mentioned there was a family night with over 300 people and tomorrow the Pittsburgh marathon volunteers will be in for a field day and that concludes my report. Mrs. Sturgess concluded. I

want to thank our staff for everyone coming out and working after a stressful year I know as Dr. Holtzman mentioned earlier a lot of districts are struggling and a lot of business are struggling to get folks fully staffed in a lot of different areas across the country so I'm really pleased that our teachers made a commitment and were able to offer full-day programming to many of our students and thanks to Dick's Sporting Goods for their contribution.

We did meet this evening upstairs and reflected on the budget we voted on tonight and went through some of the support staff contracted that we voted on tonight.
